

## Selection Criteria

The Ohio AgriBusiness Association will select no more than 20 promising leaders in the agribusiness community to participate in the Leaders Achieving New Career Heights, or LAUNCH program. The participants will be chosen by OABA's selection committee through an application review process.

## Program Outline

The LAUNCH program will consist of:

- two sessions (three days each)
- networking opportunities
- webinar(s)
- capstone project

By committing to the program, participants are expected to attend all sessions on the dates noted below, complete the capstone project and make every effort to participate in the networking opportunities.

Session dates:

1. January 15-17 - Columbus area
2. February 19-21 - Marion area

Program topics and skills practiced include: personal insight, next-level leadership skills and decision making including strategic planning, critical thinking, change management, goal setting and organizational skills; communication and presentation skills; global issues in agriculture; sales and marketing principles; Ohio/regional trends in agribusiness; state and local government; and a capstone project.

## Requirements/Application Process

Registration for this event is different than most OABA training opportunities. Those interested in participating will need to go through the following short application process:

1. Applicants must work for a member organization/company of the Ohio AgriBusiness Association.
2. Aspiring leaders will need to talk with their supervisor and/or company leadership to determine if the interested individual has approval to commit to the program.
3. Individuals must fully complete official application, which includes a letter of recommendation.
4. Applicants and their supervisors and/or company leadership must sign a letter of commitment to the two sessions.
